- That a close cooperation is held with the suppliers, so as to integrate prevention and protection processes and to make sure that the company's policy and procedures are known and applied by all the partners;
- That consistent education and growing awareness are fostered to prevent critical situations and to promptly react when incidents occur;
- That all the employees, the unions and the safety managers are actively involved into the programs and achievements about health and safety;
- That the integrated management system is regularly tested, assessed and made more efficient by will of the Directors, in order to comply with the Norms UNI EN ISO 9001, UNI EN ISO 14001 and UNI ISO 45001 regarding Quality, Environment, Health and Safety of the employees;
- That fully transparent and trust-based cooperation is enhanced between the company and the authorities, including the internal Supervisory Body (pursuant to law D. Lgs. 231/01).

In order to achieve the above-mentioned goals, Padana Tubi is committed to fulfil what the Norms require:

- Make sure that any contract is performed according to the rules and that the quality management system is consistently applied, as well as ensure satisfaction among all the people, who proudly work towards the targets;
